on the date and place designated below, with the following terms and conditions.

1. The **Parties** agree that the **School** operates an educational institution (secondary grammar school) named **Kőrösi Csoma Sándor Bilingual Baptist Secondary School** (Hungarian name: **Kőrösi Csoma Sándor Két Tanítási Nyelvű Baptista Gimnázium**), for the general purposes outlined in its operator's Statutes, which the **Parents** have been made familiar with.
2. The **School** undertakes to provide to the **Parents'** child named and identified below, and hereinafter referred to as: **Student**, the educational services and other related basic services that pertain to the International Baccalaureate (IB) Diploma Programme, as specified in the School's Pedagogical Programme.

The educational services and other related basic services include especially the following:

- small-group classes as required by law, which are compulsory and accredited in the IB system;
- extracurricular programmes related to IB requirements;
- access to the facilities and equipment of the **School**.

3. The present Study Contract shall be concluded for a definite term, which is the whole duration of the IB programme.
4. The present Contract shall become effective upon the date this Contract is signed by the **Parties**.
5. The term of the present Contract shall terminate with the termination of the IB programme.

6. The **Parties** agree that the present Study Contract is concluded for **Academic Year(s) 2017/2018 and 2018/2019**.
7. Apart from the basic services specified in Section 2, the **School** shall provide additional extracurricular classes and organize free time activities upon student request and interest, for an extra charge. Such additional services and activities may include, for example, the organization of student associations, subject groups, arts and crafts groups, sports associations, field trips, language camps and creative camps.
8. The **Parents** have inspected the premises of the **School**, including its rooms, furniture and yard, and are familiar with the **School's** facilities and conditions. In addition, the **Parents** have been fully informed of the financial, infrastructural and technical parameters and requirements of the education provided by the **School**.
9. The **Parents** agree and accept that the **School** shall organize some of the sports, creative and social activities related to the students' required CAS (Creativity, Activity, Service) module outside of its premises.
10. The **School** declares that it has at its disposal all the resources and infrastructure required for the organization and provision of high-standard educational services as specified by the International Baccalaureate Organization (IBO).
11. The **Parents** shall undertake the joint obligation to pay to the **School** a **tuition fee of 3,000 EUR (three thousand Euros)** per academic year for the duration of the **Student's** registered student status. The tuition fee is payable at least 14 days prior to the commencement of the current academic year. (*The School's bank account is IBAN: HU 70 1030 0002 1063 2888 4882 0013; SWIFT code: MKKB HU HB.*)
12. The **Partners** agree that the extracurricular activities specified in Section 7, as well as the school meals and course books, shall be available upon payment of the respective extra charges or service fees indicated on the **School's** website at www.ibkorosi.hu.
13. The **Parties** agree that the obligation to pay the annual tuition fee specified in Section 11 – given that its sum is payable for a whole academic year – is not conditional on the number of school days actually spent at the **School** by the **Student**.
14. The **School** agrees that it shall not modify the tuition fee payable by the **Parents/Student** for the duration specified in Section 6 of the present Study Contract.
15. Upon signing the present Study Contract, the **Parents** shall undertake an unconditional and irrevocable obligation to pay the tuition fee for the duration specified in Section 6.
16. The **Parents** shall fulfill their unconditional and irrevocable obligation to pay the tuition fee for the whole duration specified in Section 6 even if the **Student** shall not use the educational services provided under the terms of the present Study Contract for the whole duration of the IB programme, for any reasons for which the **School** cannot be held

accountable. The **Parents** shall be exempted from this provision only on condition that they submit a request for payment exemption to the **School**, and the **School** grants their request.

17. In case the **Student** engages in self-study in any of the subjects, and therefore does not participate in classes in the given subject, his/her self-study does not modify the tuition fee payable according to the provisions of Section 11 of the present Contract.
18. The **Parents** may be granted permission on a case-by-case basis, and upon written request, to fulfill their payment obligation undertaken upon the signature of the present Study Contract by way of paying the tuition fee in installments.
19. The **School** informs the **Parents** that a separate stipend and study contract may be concluded if a grant is awarded within the framework of an open grant program organized and supported by the **School** and the Local Government of District 3 of Budapest.
20. The present Study Contract shall be amended or modified by the mutual agreement of the **Parties** only in writing. The **Parties** shall exclude the possibility of modifying or amending the present Contract electronically.
21. The **Student** shall obtain and maintain his/her registered student status on condition that the payment obligations specified in the present Contract are fulfilled.
22. The **Parents** shall fulfill their payment obligations either by means of wire transfer to the **School's** Euro bank account specified in the present Contract, or in cash at the **School's** cash desk. The Parties agree that in case of a wire transfer, all related transfer (banking) costs are payable by the **Parents**.
23. The **Parties** agree that the **Parents** have been made familiar with the **School's** Regulations and shall abide by its provisions. The **Parents** shall endeavour to make the **Student** familiarize himself/herself with the Regulations and comply with its provisions.
24. The **School** shall have the right to terminate the present Contract with immediate effect if the **Student** regularly or continuously violates the **School's** Regulations or disrupts its educational order in the course of his/her registered student status, or commits a serious violation, and if the violation/disruptive behaviour is not terminated after a written notice sent to the **Parents**, or if the **Student** is found guilty of a crime or administrative offense by law. The termination of the Contract shall modify the **Parents'** payment obligations under the present Contract only to the extent that upon such termination of the present Contract, all the tuition and other outstanding fees and charges payable for the whole term of the Contract shall become payable immediately and in one installment.
25. The **Parents** shall undertake to fully compensate for the damage caused by the **Student**.
 - a) Such damage may especially include material damage caused by the **Student** with his/her violatory or disruptive behaviour specified herein, or by other means; or

b) damage caused by the **Student** to a third party that the **School** is liable to compensate for.

c) Damages are payable to the **School** in addition to all the payment obligations specified in the present Study Contract.

26. In case the **Parents** wish to unilaterally terminate the Study Contract, they shall notify the **School** in writing. In the event of such termination, all the payment obligations for the whole term of the present Study Contract shall become payable immediately and in one installment.

27. The **Parties** agree that, apart from the cases specified in Section 22 of the present Study Contract, the **School** may unilaterally terminate the Study Contract with immediate effect only if the **Parents** fail to fulfill their unconditional and irrevocable obligations under the present Study Contract, especially if they fail to fulfill, after two written notices, their payment obligations specified in the Study Contract.

28. Matters not regulated in the present Study Contract shall be governed by the relevant provisions of the Hungarian Civil Code.

The **Parties** agree that the present Study Contract has been issued in Hungarian and English, and the **Parties** shall accept only these versions as authentic and prevalent.

Following perusal and interpretation, the Parties have signed the present Study Contract as one being in full accordance with their respective will.

The present Contract has been issued in two (2) identical copies, one of which is received by the **Parents**, and the other is retained by the **School**.
